



City of Vincent Modern Cloth Nappies Rebate

Whether you choose to hire, purchase or repair reusable nappies each option supports sustainable living and waste minimization.

Aims of the Rebate:

- To assist residents in a transition away from single-use plastic-based products to reusables.
- To educate residents to the many Reusables Nappy Products and servicing options and their ease of use and convenience compared to single-use products.
- To introduce residents to the opportunity of cost savings that reusable products can provide over time.
- To divert single use nappy waste from landfill.
- To minimize the risk of single use plastics entering the local environment.
- To reduce plastic consumption in our community, including that in the single use products themselves as well as their packaging and wrappers.



How to claim your Modern Cloth Nappy Rebate

Make your purchase of any Modern Cloth Nappies / service from your chosen retailer. Obtain a valid tax receipt, listing the items purchased.

Fill in the Modern Cloth Nappy Rebate form and email the completed form to waste.enquiry@vincent.wa.gov.au along with:

- Valid itemized tax receipt **dated within the past 12 months.**
- Proof of City of Vincent residency (eg. Current driver's license, recent rates notice or utility bill).

Terms & Conditions:

1. This Modern Cloth Nappies rebate is available only to current City of Vincent residents.
2. Rebate is applicable for Modern Cloth Nappies hire/purchases/repair made within 12 months of the application. The rebate cannot be paid on purchases made prior to this date.
3. A rebate of up to a maximum amount of \$100.
4. One rebate for Modern Cloth Nappies available per household in the City of Vincent.
5. Proof of City of Vincent residency required (e.g. driver's license or recent rates notice / utility bill).
6. A valid tax invoice must be provided showing details of the items purchased.
7. Rebates will be processed by the City's Finance team in accordance with current processes. This may take several weeks to process.
8. Rebate will be sent via EFT to your nominated bank account and may take up to 4-6 weeks.
9. Rebate is only applicable for the Modern Cloth Nappies /services and not for any other related postage cost.
10. Allocated budget for this rebate for the current financial year is to a maximum of \$5000. Rebates are allocated on a first come, first served basis. City of Vincent reserves the right to decline a rebate once this capped amount is reached in the current financial year.
